

## <u>Report on Students Satisfaction Survey on Institutional Quality Assurance – 2019-20</u>

As part of NAAC requirements, a Satisfaction Survey on institutional quality assurance was conducted among students, regarding the Coverage of curriculum and syllabi in the discipline 75% of the students responded pro-actively, 81% of the students reciprocated regarding the effective communication of teachers, related to topics such as effective use of black bard, video presentation, power point presentation and other internet sources.

82% of the students gave a healthy feedback pertaining to the extension of clinical, preclinical and practical lab facilities, available in the College.

As part of academic, social and personality growth mentor-mentee was constituted and a survey was conducted among clinical students and 86% of students commented that a one to one interaction with the mentor has helped them immensely in overcoming academic hurdles. 84% of students in a random survey mentioned about the merits in outdoor learning initiatives like community outreach programmes, study tours and attending national students conferences.

90% of students emphasized the value of Value Added Courses like Professional ethics, Personality Developments of rural health care, fairness of internal examination process practiced by the teachers was enquired in the students community and 72% of the responders commended positively.

91% of the clinical students mentioned that the College meticulously prepared examination halls, invigilatory duties, evaluation of internal answer papers and addressing examination related grievances.

Regarding to overall teaching learning and evaluation 80% of the students gave 4 stars rating and 7% of the students gave 5 stars rating.
