S.O.....In exercise of the powers conferred by sub-section (2) of section 10 of the Dentists Act, 1948 (16 of 1948), the Central Government, after consultation with the Dental Council of India, hereby makes the following amendments in Part-I of the Schedule to the said Act, namely:-

Master of Dental Surgery (Oral Pathology & Microbiology) (with 3 seats if granted on or after 17.06.2014)	MDS (Oral Path.), Kerala University of Health Sciences, Thrissur
Master of Dental Surgery (Oral & Maxillofacial Surgery) (with 3 seats if granted on or after 20.06.2014)	MDS (Oral Surg.) Kerala University of Health Sciences, Thrissur
Master of Dental Surgery (Oral Medicine & Radiology) (with 3 seats if granted on or after 20.6.2014)	MDS (Oral Med.) Kerala University of Health Sciences, Thrissur
