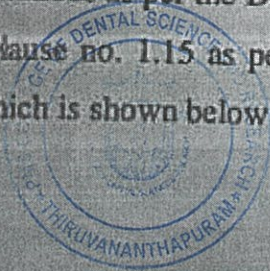
Meeting started at 2.10 PM. Chairman welcomed all the members of the Board and presented the following agenda through the screen sharing option of Zoom platform for discussion:
