



Where, both the Organizations have formulated a **SCHEME** (hereinafter referred to as scheme) under which the individuals who are the residents of Second Party and enrolled under the scheme either individuals or in-groups are provided with treatment benefits in special rate. BS 756353

It is agreed and between the parties as follows: -

1. As per mutually agreed conditions of the SCHEME, The First Party shall provide free Dental & Medical consultation and for all normal extraction, Discount for other Dental treatment will be as per the attached Annexure - 1
2. That the Second Party shall provide to each member, of the scheme, with an identification card with recent photograph of the member, his/her name, age, sex, validity and card no. duly signed by the member and attested by an authorized person of Organization which shall be presented for purpose of assisting the Health Care Provider in verifying member eligibility. For any verification or clarification with regard to the status/eligibility of any member of the scheme during the validity period of the scheme the Health care Provider should correspond with the Ashram.
3. The Ashram shall provide thirty days (30 days) advance notice to the Participating Health Care Provider of any changes in covered services or conditions of coverage applicable thereto and vice versa.

4. That the Health Care Provider after due verification of the member's eligibility by verifying all the details given on the identity card and give the member appropriate dental treatment at mutually agreed discounted rates.
5. In case the first party finds any tamper, false or incorrect information or anything to that effect in the identification card of any member of the scheme, the Participating Provider Hospital shall immediately inform the Second Party on which the Party of Second Part shall take necessary steps and intimate the First Party with regard to the eligibility of the member.
6. The First Party shall give free treatment for normal extraction of the Teeth and also for the consultation at the Dental & Medical OP. For all other dental treatments, a 30% discount on the treatment charges will be provided to the residents of the Ashram and a 50% discount to the patients who are referred through our dental camps.
7. While making a claim the First Party shall drawn the claim as permissible under the rate card (hospital Tariff) and permitted by the party of Second Part at the time of agreement.
8. This MoU shall be in force from the date herein above mentioned and either party can terminate the MoU with a one month prior written notice to the other party.
