ORDER

As per the notification read 1st above, the University had invited applications for granting Continuation of Provisional Affiliation to conduct Dental UG and PG courses for the Academic year 2021-22.

The modified Amendment Statute for Affiliation of Colleges stipulates conducting of inspection for granting Continuation of Provisional Affiliation in every year in all college except those colleges where the first the first batch of UG/PG/Super Speacility courses has not passed out. It was also decided that in such colleges, inspections will be conducted every year till the first batch has passed out.

The Governing Council, in relaxation to the above, vide decision read 2nd above, had decided to grant Continuation of Provisional Affiliation for the Academic year 2021-22 to colleges with courses having recognition of Government of India and to grant Continuation of Provisional Affiliation for the Academic year 2021-22 without conducting inspection, subject to receipt of renewal permission/recognition from Government of India considering the prevailing Covid situation.

In the circumstances, sanction is hereby accorded to the below mentioned colleges, who are eligible to be considered in accordance with the GC decision read 2nd above, to grant Continuation of Provisional Affiliation to conduct Dental UG and PG courses for the academic year 2021-22.

The colleges shall strictly adhere to the general conditions at detailed below:-

i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the rules and regulations of the University from time to time, failing which the affiliation granted will be cancelled.

ii. In the light of the direction of the Hon'ble Supreme Court of India in Writ Petition (C) nO. 656/1998, the institutions shall take appropriate measures for the prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawl of affiliation of the College will be initiated.



iii. Affiliation granted is strictly provisional and only for the academic year 2021-22. The colleges have to apply for Continuation of Provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of Letter of Approval from apex bodies concerned.

iv. The colleges should remit annual administration fee fixed for UG /PG courses for the academic year 2021-22, if applicable.

v. Admission to the next academic year shall be made only after obtaining prior permission from the University.
